



### **ClubCare Worker**

- Engage with vulnerable or marginalised individuals and families who frequently visit Club Partner venues
- Contracted until 30<sup>th</sup> June 2020
- Part-time (1 day a week) based in Campbelltown

The ClubCare Program aims to identify and engage with patrons who may be exhibiting risk factors related to gambling, alcohol and other relevant issues in order to promote the well-being of the community. As a ClubCare worker, you would provide information, referrals, debriefing and counselling to patrons and their family members. In this position you may also facilitate workshops and/or group programs to address common themes observed across the Club community.

The ClubCare worker uses an assertive outreach model, where they provide initial access to information and support for participants and then refer them to specialist, appropriate Services for ongoing/continued support. The program is not designed to provide long term, intensive therapeutic or case management support to people experiencing acute mental health episodes. In these instances the program takes a crisis intervention approach and attempts to link the client in with specialist services.

The program is based on a partnership between Clubs and CatholicCare Sydney.

CatholicCare Sydney is the official social services agency of the Catholic Church in the Archdiocese of Sydney. We are a leading not-for-profit agency providing care and support to people in Sydney across a wide range of social services: Children and families, relationships, ageing, disability, employment, mental health and youth programs.

This role is part-time (1 day per week – preferably on Thursday 11am-7pm) until the 30<sup>th</sup> June 2020, with a potential for additional hours in the future. This role will also include access to salary packaging.

#### **Successful applicants will have the following:**

- Ability to undertake the duties of the role in accordance with CatholicCare's Mission, Vision and Values and its Code of Ethics and Conduct
- University Qualifications in Social Work, Psychology, Social Welfare or equivalent
- Experience and skills related to engagement, case work and counselling
- Understanding and/or experience related to gambling related harms, alcohol and other drugs and associated issues
- Experience facilitating group programs, workshops and events
- Ability to effectively communicate and collaborate with a range of stakeholders and referrers internally and externally
- Demonstrated experience in working with culturally and linguistically diverse communities and with Aboriginal and Torres Strait Islander communities.
