In addition, to support school communities during and after a critical incident and to liaise with other agencies and services where appropriate.

Also operated by CatholicCare across all primary schools in the Eastern Region, and both Primary and Secondary schools in the Southern Region, is our STAR program (Students at Risk), an intensive program which improves outcomes for students considered to be at serious risk of their learning being disrupted by behavioural or social/emotional issues. Crucially, students are provided with therapeutic interventions and support that complement both their learning and home environments.

- Supports student wellbeing by providing
 - counselling services and referral to students, family members and advice to school staff as directed by the Manager or Principal
 - o related services to the school community including small groups for students and social-emotional education for parents and the school

- o relevant information to the students, staff and parents.
- May be based in one school or work across multiple locations
